**Cleaning:**

- Do not use window cleaning fluids (Windex, 409, etc) or any solvents (gasoline, denatured alcohol, acetone, etc).
- Never use abrasive cleaners, abrasive pads, or gritty cloths.
- Never use razor blades, scrapers, squeegees, brushes, etc.

1. Thoroughly rinse Roof to float off dirt and mud.
2. Using a soft cloth, or microfiber cloth, clean Roof with warm water and a gentle detergent. Baby shampoo or hand washing soap are recommended.
3. To prevent water spots, use a chamois to blot Roof dry.




Rubber must face Roof when installing Sealing Washer

- Install one continuous piece of Seal around Roof as shown.








- Install Gasket to inside of Visor Panel as shown.



- Install Clamps and Brackets to Roof with hardware shown.



- Place Roof onto machine.
- Roof will install under Visor Panel.
- Secure with stock hardware.



- Secure Clamps to Frame.
